The purpose of the 7-days seminar is to provide participants with the basic know-how, expertise and good practices taught by researchers, experts and professionals active in the specialized field of the use of music as an additive treatment modality in the detoxification and rehabilitation processes of individuals suffering from drug dependence. Each of the seminars will provide 39 hours of training and participants will receive a certification of attendance upon completion of the seminar.

The final selection of the total of (30) participants (from France, Greece and England) in the second session of the 7-day seminar will take place after evaluation by the University of NIMES, and according to the proposals made by the partners.

- Music Skills and Experience as proven by relevant certificates [percentage 20%]
- Knowledge of English or/and French as proven by relevant certificates [percentage 30%]

For those participants, who meet the necessary prerequisites of previous employment or organic connection with the partners holding citizenship from Greece and/or England, transportation and living/accommodation expenses will be covered respectively for 12 individuals (maximum) from University of Macedonia, 6 individuals (maximum) from G.H.Th. "G. Papanikolaou" and 15 individuals (maximum) from England, according to what is stated in the agreement of the project.

The current call will be uploaded in French, Greek, and English language. Candidates who will apply for transportation from Greece and England to NIMES, FRANCE in order to attend the second 7-days seminar at the University of Nimes, must be able to present by documentation (with a certificate of their institution) the employment relationship with the partner of the Program in the corresponding country, in order for the transportation and living/accommodation expenses to be eligible, according to the regulations of the Erasmus+ Program, Key Action 2 (KA2/BΔ2).
